1. RCC Service Level Agreement

This was read out by Alison having been agreed previously and will be signed at the next Parish Council meeting. The importance of the NDP being a document determined by the whole village was stressed - all procedures will be open and transparent. In addition the content will be agreed by residents of both Barrowden and Wakerley via a referendum and not driven by minority bodies. Funding is a bridge to be crossed and should be planned for.
