2. Minutes of the previous meeting 6th September 2017:

3. Matters arising not covered in the Agenda:

- Lorraine Cornwall archaeology list circulated to the Group on the 28/09/17. GB suggested a map would be helpful and the tanning information would be researched by CD.
- Open Green spaces proposal now agreed.

4. Approve amended N/Plan Vision and Objectives document

- the context should be enlarged
- special portrait to be done which would help set the scene CD would assist with this
- consistency comes out and this improves readability
- possible use of lead in sentences CB and GB to look at this
- meeting also felt that community aspirations should be included so that it is bespoke to B&W (weave them into the chapters) watch out for RutCC Cabinet disapproval

• GB commented :-

- a. Environment flooding in Wakerley, nothing obvious
- b. Tree preservation order in Barrowden, Wakerley?
- c. Leisure and Recreation all community aspirations
- d. Residential Development -added Policy 7
- e. Transport mainly policies of aspiration but add changes to policy 1 access to village turning off main road travelling west to east
- f. Landscape Assessment tidying up work to be done for the November Meeting

 regards limitations because of mineral deposits. Basically viewed as a long term
 project with the MOD and nothing much will happen before 2021 when the
 infrastructure will be tackled first.
